



MISSION STATEMENT: To provide an electronic network to those dedicated to the improvement of the sniping profession, and thus further the law enforcement and military sniping knowledge base.

Snipersonline U.A. is a Non-Profit educational association dedicated to the law enforcement and military sniper. We provide information and networking resources at low to no cost to qualified individuals by providing a restricted community in which professionals can feel free to share. The association provides a discussion style email mailing list and forums that archive information on a secure website. We provide for the free and open exchange of ideas, information, and opinions on matters that are relative to the sniping field faster then ever before possible.

ASSOCIATION RESTRICTIONS AND RULES:

- Restricted to those individuals actively participating in the field as a: sniper (military or law enforcement), sniper instructor, commander in charge of snipers, or an individual who's specific knowledge will be of benefit.
- Each member of the association must apply to be added to the list. The application must contain a written request outlining the applicant's duties or interest that would make them eligible for membership (IE: swat team sniper, . . .) and a photocopy of the applicant's departmental, or military ID. Each applicant will be judged independently by the association before being added to the list.
- In order to maintain control over access to the possible sensitive nature of the discussions therein, the association moderator reserves full control over the list.
- The major topic of the association shall be sniping. Discussions on matters other than, but relative to the main topic are allowed until they detract from discussions.
- All members are encouraged to post freely and openly any information, ideas, or opinions that are beneficial.
- The association agrees to use the most current protection software to protect the applicant. By submission of this application the applicant agrees not to hold the association or its representatives liable for damages that may occur upon the transfer of a malicious virus through the association software.
- Inappropriate vulgarities, spamming, or other unprofessional behavior will cause the offending party to be removed from the association. The association moderator has full rights to judgment of conduct on the list and to the disposition of consequences for violations of the behavioral code.
